 As per the Varun Tej Good complaint, on 5th September 2019, he went to canteen around 11.50 am, at coffee day premises one of the aggressor, called to Varun Tej Good, then Varun requested them that he will be back to them after keeping his bag in canteen, but the Aggressors refused his request and started abusing with Varun using abused language and dragged him to beside cfc kiosk area, immediately 3 aggressors physically attacked to Varun..

Varun was injured by the physical assault of the 3 Aggressors, the major injury is because of punch given by Rohith Reddy vicrey caused severe damage on the nose of the Varun. and he had small plastic surgery with sutures. The 3 Aggressors are C. Rohith Reddy (16241A0212) of IV B.Tech (EEE), D. Vishal Reddy (16241A0414) of IV B.Tech (ECE) and Ch. Pranay Kumar (16241A0109) of IV B.Tech (CIVIL)

After getting the complain from Varun Tej Good immediately principal formed Enquiry Committee on the same day.

The Discipline Committee Enquiry started on same day and next two days.

The committee asked to all eyewitnesses and check the CC camera footage on incident happened day. After that the committee give complete report on 7th September 2019 to principal with letter NO GRIET/DSC/12/B/19-20. Based on above committee recommendations today Board Committee interacted with all aggressors and victim Varun Tej
