2. An Expert Team conducted on-site evaluation of the programmes during 13th-15th May, 2016. 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The programmes have been granted provisional accreditation for 2 years. Gokaraju Rangaraju Institute of Engineering. & Technology, Kukatpally, Hyderabad Telangana should also submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above, In respect of UG Engineering programme, it may require submission of pre-qualifier before sending the Compliance report for granting further Accreditation.

The accreditation status awarded to the programmes as indicated in the above table does not imply that the accreditation has been granted to Gokaraju Rangaraju Institute of Engineering & Technology, Kukatpally, Hyderabad, Telangana as a whole. **As such, the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is programme accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name of the programme(s) accredited, level of programmes and the period of validity of accreditation, as well as the date from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.
6. The accreditation status of the above programmes is subject to change on periodic review, if needed by the NBA. It is desired that the relevant information in respect of accredited programme as indicated in the table in paragraph 2, appears on the website and information bulletin of the Institute.
7. The accreditation status awarded to the programmes as indicated in table in paragraph 2 above is subject to maintenance of the current standards during the period of accreditation. If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.
8. Copy of the Report of Chairman of the Visiting Team and Evaluators' Reports in respect of the above programmes are also enclosed.
9. If the Institute is not satisfied with the decision of NBA, it may appeal within thirty days of receipt of this communication giving reasons for the same and by paying the requisite fee.
