2.	Review of perspective planning, TEQIP - II grant	Member Secretary informed the members about the progress of activities under TEQIP-II. Dr. K.G.K Murti, TEQIP coordinator read out the relevant points of review meeting by SPFU in Dec 12. The pace of activities has already picked up, He drew the attention of all the programs not listed in IDP, but cleared in the two special GB meetings held in Sep and Nov 12. He confidently informed that the Rs. 40 lacs, the first release of TEQIP grant shall be spent fully and may be few thousands more he opines by 31 March 13. The four funds are augmented as per TEQIP divisions and the position is 1. GRIET Corpus Fund Rs. 19,99,917 2. GRIET FDP Fund Rs. 14,25,875 3.
