#### **Day 1: 18Aug 2016 (Thursday: 9am – 6pm)**

GRIET, TEQIP-II Coordinator Mr. V.Vijaya Rama Raju welcomed the Data auditor, Mr. N. Ramana, Department of Computer Science, Kakatiya University. The particulars of Data audit forms were examined and verified for the academic years 2014-15 and 2015-16. Also a consolidated report has been prepared for the academic years 2010-11 to 2015-16. The data audit report covered information about UG programme, PG programme, placements, faculty, accreditations, research, patents, IRG, four funds, etc.

#### Day 2: 19Aug 2016 (Friday: 9am – 6pm)

GRIET, TEQIP-II Coordinator welcomed the Performance auditor Dr. Sounak Kumar Choudhury, Prof., Department of Mechanical Engineering, IIT Kanpur and introduced him to Prof., P.S. Raju, Director, GRIET and Mr. N. Ramana, Data auditor.
