Vice Principal is notified of the complaint and the students who were ragged were interviewed on the issue and a written complaint was taken from them individually on 19/10/2016.

A photo identification of the accused in this complaint was done by the complainants individually on 15/11/2019.


**Incidence:** On 18 October 2016, The complainants from Ist year were having lunch at the Café Coffee Day kiosk on campus when the group of four accused mentioned above accosted them and offered chewing gum to one of them who reluctantly took it, another student to whom it was offered fumbled and the gum fell down, at this the seniors asked it to be picked up at which there was resistance from the junior student. The incidence slowly changed to aggression when another student was asked for his biodata and refusal to do so incensed the senior group and they resorted to physically manhandle the juniors. The Juniors upped the ante challenging them which led to shouting and use of abuses in front of the gathering crowd. The situation was normalized temporarily with apologies, but it is said that Haroon Hussain of Civil accosted them and said they have to come outside the college for settlement of issue. They asked the Ist years to move out of the campus to a Kiran shop in the near by colony where they had assembled more of their friends. The Ist years slipped out of the gate at about 2:00 to 2:30 pm on 18 October without being stopped by security, took their vehicles parked outside the gate and went to the designated place. At this place they were asked to apologise, while Mr. Saicharan who had some grudge rushed to hit one of the juniors which was blocked by other Ist years, at this Mr. Asif Khan slapped Mr. Sri Sai Teja followed by use of abusive language by the assembled gang. They were asked to leave. This culminated in the filing of complaint by the father of Mr.Sri Sai Teja.

Meanwhile Mr.Asif Khan was called by HOD Mech and issued a warning for which he has admitted of ragging and apologised. Similarly the father of Mr. Haroon Hussain met the HOD CSE and me and pleaded ignorance of the act. Mr.Sai Charan is not reported to his HOD nor has Mr.Adeeb Hussain.

In this regards I am issuing the letter of suspension of the student from taking the supplementary exam till the investigation is complete.
